Awardability of all contracts for Department projects is contingent upon the business meeting any licensing and/or prequalification requirements to perform in the respective work

By the anniversary date of your certification, (**October 27th** yearly) you must submit a Michigan Unified Certification Program (MUCP) Annual DBE Affidavit and a complete copy of the current year 1040 personal tax return for all owners and the current year business tax return with all schedules to MDOT, Office of Business Development, affirming there have been no changes in the company's circumstances which affect size standard requirements (SBA business size criteria and overall gross receipt cap), disadvantaged status, ownership status, or control requirements based on Federal Regulation 49 CFR Part 26. The Annual Affidavit can be download from our website www.michigan.gov/mucp (click on Download Forms).

You are required to notify MDOT Office of Business Development, Lansing office toll free at 866-323-1264 or 517-373-8546 or via facsimile to 517-335-0945 Attn: Bethany Anderson, of any and all material changes to your business status / structure within thirty (30) days of the change. These changes include but are not limited to: the physical location, telephone and or fax number of your business, ownership, officers, Directors, key personnel, management, scope of work performed, daily operations, on-going business relations with other firms or individuals, etc. **The notice must be in the form of a notarized affidavit and you must attach supporting documentation describing in detail the nature of such changes.** Not providing this information may be grounds for removal of your DBE eligibility based on a failure to cooperate, pursuant to Federal Regulation 49 CFR 26.109(c).
